Joey G – said he and Danny were members

JW – Continued to press why we need to vote on this today, we had until November 6<sup>th</sup> per the judge

RS - Called for a vote

DT - Voted yes

RS – Yes

JW - NO

Motion passed to accept the Settlement Agreement by LG

**PUC Compliance** 

RS was looking for an extension

JW asked why – this is not a legal Proceeding. JW Explained what the Compliance was and what it wasn't

RS - continued to Question the Compliance Filing claiming the PUC will "take over" the WOWSC.

- JW Clarified that they will not take over
- DT Was asked if she read it. Answer No
- JW Asked DT why she had not read?
- JW Asked if DT and RS read my proposal either one answered.
- JW Encouraged the Board Members to speak with the PUC as to what this was
- RS Said he would
- RS Stated that there were falsehoods in the filing
- JW Asked what they were
