

Windermere Oaks WSC Operator's Report September 17, 2024

AWR Acquired by Si Environmental

As communicated previously, all AWR employees have made the transition to Si Environmental. Si Environmental operates 130 utility districts primarily made up of family own companies that they have acquired in Houston.

All that needs to occur is the assignment of the contract from AWR Services, Inc to Si Environmental that is included with the packet. There is no change in contract or pricing.

Drought Update

The Board approved the amended Drought Contingency Plan (DCP) at July 29 Board meeting.

The Corporation is currently allowing once per week irrigation under the previous DCP. Since the combined storage levels have maintained over 1.1 million acre-feet for the past two months, we recommend the Board consider moving back up to Stage 1. This would allow customers to irrigate twice per week irrigation following the assigned days and hours within the plan.

Windermere Oaks WSC Irrigate outdoors using automatic or manual irrigation systems or hoseend sprinklers no more than <u>Twice per week</u> for up to **15 hours** only during scheduled days and times as indicated below:

Residential- automatic irrigation systems

Odd number addresses: Wednesdays and Saturdays Even number addresses: Thursdays and Sundays

<u>Commercial/Schools/HOAs</u> (including large landscapes such as HOA common areas and public schools)
Tuesdays and Fridays

Watering Hours

Midnight to 10 a.m. and 7 p.m. to midnight

As of September 15, the combined storage level of Lake Travis and Lake Buchanan is 1,125,794 acrefeet which is 56% full. Lake Travis is at 550,001 acre-feet which is 49% capacity. The LCRA continues to release water from upstream dams, while also releasing the Lake Travis dam. One a-f equals 43,560 cubic feet, or 325,851 gallons.

Water System - Plant

- 1. The contractor has placed the order for the parts to make the following repairs listed in our last report. The parts have a 3-5 week lead time.
 - a. Repair the motor of the clarifier Lead time 3-5 weeks.
 - b. Replace the 2" Bray Valve with EMO for air scouring Lead time 4-5 weeks.
- 2. As communicated previously, turbidity continues to be an issue for the operators and will continue until a new clarifier is constructed. When the LCRA releases water from the Starcke dam, our operators have to work overtime day and night to keep the debris and dirt (turbidity) to a minimum. It requires changing the chemical dosing up and down until the turbidity resolves. We are seeking Board approval for in the amount of \$18,804 to install new Hach turbidity meters, chlorine analyzers and controllers to help the operators manage the levels. The proposal was included in the March and June operator's reports. As a reminder, these are also listed in the TCEQ exit interview as items that should be addressed to avoid a violation.

Water System – Barge

We assisted the contractor with trying to move the barge further into the deeper part of the lake. The divers were able to untangle the lines, however, it was discovered that one of the anchors is no longer in its original position. We are awaiting the report from the contractor to share with the Board and options for next steps.

Wastewater System

The potholing of the sewer line to the sewer plant for easement purposes will be scheduled within the next two weeks.

Tap Fees

The Board will be reviewing the current tap fees and their associated costs to install. Below are the current and recommended minimum tap fees for new home construction. The purpose is to ensure coverage of all District expenses when installing taps and meters. We provided a summary of tap fees in the area for comparison with the June operator's report.
