

All action items must have been included in the Notice of Member Meeting posted 72 hours in advance of the Member Meeting in accordance with the Texas Open Meetings Act.

Members will check in with the Election Auditor who will verify whether the member has already submitted a ballot. Those members who are voting at the meeting will be provided with a ballot at the meeting.

AGENDA:

1. Presiding director calls the meeting to order at 10:00 am
2. Opportunity for each director candidate to address members (5 minute limit per candidate)
3. Report of board president
4. Presiding director makes a last call for submission of ballots from the members.
5. Presiding director announces the total number of members present as of 10:00 a.m. at the meeting and the total number of ballots received prior to the meeting. Presiding director will then announce that a quorum of the membership is present and that the meeting may proceed. Election Auditor will begin counting the ballots.
6. Approval of Member Meeting minutes of April 22, 2017.
7. Update reports
 - a. Treasurer's report of Board approved 2018 Budget.
 - b. Report of corporation manager (to include report on system's operations, update of projects and strategic plan for 2018.
8. Signed citizens and members comments (3 minute limit per person)
9. Election Results
 - a. Election Auditor provides the presiding director with a written report of the election results for director positions voted on by the members.
 - b. Presiding director announces election results.
 - c. Presiding director introduces newly elected directors and declares them as board members to assume the position of directors immediately.
 - d. Comments from the newly elected directors.
10. Closing comments by presiding director and announcement of New Board of Directors meeting to elect officers on adjournment of this meeting.
11. Adjournment.
