No motions may be accepted, or action taken on issues brought up at the meeting from the floor. All action items must have been included in the Notice Agenda of the Annual Members Meeting posted 72 hours in advance of the meeting in accordance with the Texas Open Meetings Act.

The Corporation will mail to each member one official ballot regardless of the number of memberships they hold. Only the original official ballot mailed to the member or the one provided the day of the annual members meeting will be valid. If a member has lost their ballot, a replacement ballot will be issued to the member. The member must contact the Corporation at (830) 598-7511, Ext 1 or by email at <a href="WindermereWater@gmail.com">WindermereWater@gmail.com</a> to obtain an official replacement ballot. Reproduced or copied ballots will not be accepted.

We encourage Members to vote ahead of time, but if members wish to vote in person on the day of the meeting, they will need to check in with the **Independent Election Auditor** at the Spicewood Community Center between **9:30am and 10:00am with a photo ID**. The **Independent Election Auditor** will verify whether the member's official mailed ballot has been received. If the member has not previously submitted a ballot, the member will be provided with a new official ballot. If the member has sent in their ballot but the Corporation has not received the ballot, the member will be provided with a new official ballot. Members will receive one ballot no matter how many memberships they hold.

The purpose of the meeting will be to update the membership on the business affairs of the corporation. No motions may be accepted, or action taken, on issues brought up at the meeting from the floor. All action items must have been included in the Notice of Member Meeting posted 72 hours in advance of the Member Meeting in accordance with the Texas Open Meetings Act. All public comments shall be subject to the Public Comment Policy adopted by the Board on November 20, 2019.

- 1. Presiding director calls the meeting to order.
- 2. Presiding director will ask the Election Auditor for a total of the members who have voted by mail, delivered, or in person the day of the meeting. The presiding director will report the total number of members who voted, and declare a quorum and that the meeting and election counting may proceed. The **Independent Election** Auditor will begin counting the official ballots.
- 3. Comments from citizens and members who have signed sign-up sheet to speak (5-minute limit per person).<sup>1</sup>
- 4. Approval of Member Meeting minutes of February 6, 2021.
- 5. Report of board president to summarize events and accomplishments of the corporation in the past year as well as challenges and issues going forward.
- 6. Update reports:
  - a. Report of corporation manager (to include report on system's operations, update of projects and strategic plan for 2022).
  - b. Treasurer's report of Board approved 2022 Budget.
- Presiding Director to read the February 7, 2022 Board approved Resolution declaring unopposed candidate of WOWSC election.
- 8. Election Results:
  - a. Independent Election Auditor submits offical report to the presiding officer of the election results for director position and any other propositions voted on by the members. Auditor emails written results to Board.
  - b. Presiding director announces election results.
  - c. Presiding director introduces newly elected directors, declares them as board members and announces New Board of Directors meeting to elect officers upon adjournment.
- 9. Closing comments by presiding director.
- 10. Meeting is adjourned.
